Morton's Bid at Phaythopen Auction Matched by Kirkpatrick

Mr. and Mrs. Jerry Morton were the successful bidders of a Fund in the Community Foundation to benefit the Allied Arts at the 1976 Phaythopen Charity Auction held October 22 at Val-Gene's Silver Palm Room. Morton beat out several others in spirited bidding to win his own permanent named Fund. John E. Kirkpatrick had agreed to match Morton's \$5,000 bid.

The Allied Arts Endowment Fund has been built up by contributions to the Community Foundation from Florence O. Wilson, Mrs. Clarence Roberts, Mr. and Mrs. Clark Ritchie, Mr. and Mrs. John Kilpatrick, Jr., Dr. and Mrs. John DeVore, Mr. and Mrs. Earl Sneed, Mr. and Mrs. Michael Thomas, Mr. and Mrs. Willard Scott, Mrs. Marilyn Myers, and Mrs. Mary Miles Clanton. The Allied Arts is the fund-raising organization for the Symphony, Arts Council, Art Center, Theater Center, and Science and Arts Foundation.

This sustaining fund for the arts now totals \$29,695. The Community Foundation trustees strongly support the Allied Arts concept and have awarded them grants since 1971 totaling \$21,000. Salute To A Donor: Margaret K. Replogle

Margaret K. Replogle has seen her Fund work for the past six years. She has watched her contribution dollar stretch, and knows that she will be remembered long after her initial gifts to the Foundation were made.

In 1970 Mrs. Replogle contributed \$1000 to begin a Fund for the Salvation Army. Each year that worthy organization has received a grant from the Community Foundation. The earnings from her Fund augmented by money available from non-designated funds have provided a new trampoline for youth activities, materials for the Senior Citizen program, helped pay for a bus for the Boy's Club, and other services. Mrs. Replogle wisely understands the concept of the



"gift which keeps on giving" instead of being quickly used, and too often, quickly forgotten.

In 1973, 1974 and 1975 Mrs. Replogle made gifts of stock, receiving the full market value of the securities as a charitable contribution. She began the World Neighbors Endowment Fund and acted as a catalyst to attract additional donors to this Fund. World Neighbors, based in Oklahoma City, educates persons in underdeveloped countries to assist themselves. The Community Foundation has provided World Neighbors with funds for motivational films and materials.

"From little acorns" has grown a mighty impressive list of accomplishments. Perpetual giving to the charities of her choice appeals to Margaret K. Replogle. Others emulate her judgement and generosity.

World Neighbors Gets Mileage from Foundation Dollar

Here is a modern day "loaves and fishes" story. For sometime World Neighbors has been working with the Guatemalan Presbyterian Church in the Agape extension program. Last year World Neighbors provided \$118 to a women's group in Sebilias, Guatemala to plant potatoes.

From a little more than two acres, the women's group harvested 24,000 pounds of potatoes. Each member received 500 pounds for home use. The group gave 250 pounds to the Presbyterian Church of Sibilias and a tithe of \$40 to the Agape program. They also purchased a hand sprayer for pest control and saved 2800 pounds for next year's seed.

And, to top it all off, the group repaid the loan in full, including interest! But, there's more. The women had enough left over to deposit \$100 in their own treasury. All this from a \$118 loan.

Here is one more proof that the right seed sown in the right spirit really multiplies. Ever since Margaret Replogle began the World Neighbors Endowment Fund in 1970, that "seed" has been growing. John E. Kirkpatrick, Jack Dahlgren, An-Son Petroleum and Robert D. Crowe have added to the Community Foundation's World Neighbors Endowment, and it now totals \$22,743. In 1971 the Community Foundation awarded its first grant of \$1000 to World Neighbors, and has been awarding them grants continuously since. The Community Foundation and World Neighbors join in offering a hand up through self-help.
