



Florida M. Knight



A successful businesswoman, Florida M. Knight believed in helping those less fortunate. A native of Pittsburgh, Pennsylvania, Mrs. Knight moved to Oklahoma City in 1909 and came to love her new community. In 1924, she became the owner of a paint and glass company and eventually built and owned several commercial properties in downtown Oklahoma City.

A noted child advocate, Mrs. Knight wanted to improve the health and well being of disabled children in Oklahoma City. She was proud of her properties, particularly a building located on Park Avenue. In her will, she directed that the income from that building be used to establish a fund to help disabled children in the community.

Mrs. Knight died in 1964. Her property no longer exists and she has no remaining family in the community yet, because she had the desire to help disabled or handicapped children, her charitable giving continues 40 years after her death. THE CHILDREN'S CENTER



A medical situation that requires moving a child from its home to a resident facility can trigger strong feelings of grief, shock, guilt and anger for the child as well as the family. The staff at The Children's Center is witness to such emotions with each patient placement at the non-profit pediatric hospital. Thanks to a recent grant from the Florida M. Knight Trust, a licensed professional counselor is now available to help both the family and the child.

The counselor addresses significant emotional reactions and works to develop immediate strategies to help the family and child cope during the difficult time. The center cares for children age birth to 18 who have disabilities or handicaps as a result of birth defects, traumatic accidents, physical abuse and neglect and illnesses. Already the counselor has

provided one family with the tools necessary to deal with the trauma of their child's condition and its impact on the family.

"Our counseling sessions gave us the opportunity to share our emotions with each other regarding our child's accident," the father says. "Although we thought we were communicating with each other, we were still unaware of our feelings. The counselor provided an environment where we could talk openly and understand each other's emotions."
