### ELIGIBILITY:

- Applicant must provide direct services to individuals with developmental disabilities.
- Organization must be located in the state of Oklahoma.
- Applicants must be a 501(c)(3) nonprofit organization, an accredited public or private school or other publicly-supported agency.

*Grants up to \$8,000 will be awarded.*

- Environmental and Recreational Adaptations
- Classroom Cognition & Developmental Equipment
- Sheltered Workshop Equipment and Activities
